

STORAGE FLEET PRIVACY POLICY

This policy describes the privacy practices of Storage Fleet, LLC (“Fleet”) in its provision of online and software-based programs and related services. This Statement of Privacy applies to data collection and usage of information that is gathered through: (i) the Fleet website located at www.storagefleet.com including any online tools or software accessed through the website, and (ii) Fleet software programs that interface with the Fleet website or servers through your internet browser or server. By using the Fleet website and software, you consent to the data practices described in this statement.

Collection of your Personal Information

Fleet may collect personally identifiable information, such as your name and e-mail address. If you purchase Fleet’s products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. We may gather additional personal or non-personal information in the future. Information about your computer hardware and software may be automatically collected by Fleet. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Fleet website.

Fleet encourages you to review the privacy statements of websites or software you choose to link to from Fleet’s website or software so that you can understand how those websites and programs collect, use and share your information. Fleet is not responsible for the privacy statements or other content on websites or software outside of the Fleet website and software.

Use of your Personal Information

Fleet collects and uses your personal information to operate its website(s) and deliver the services you have requested. Fleet may also use your personally identifiable information to inform you of other products or services available from Fleet and its affiliates. Fleet may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Fleet does not sell, rent or lease its customer lists to third parties.

Fleet may share data with trusted partners to help perform statistical analysis, send you email or provide customer or billing support. All such third parties are prohibited from using your personal information except to provide these services to Fleet, and they are required to maintain the confidentiality of your information.

Fleet will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Fleet or its website (s); (b) protect and defend the rights or property of Fleet; and, (c) act under exigent circumstances to protect the personal safety of users of Fleet, or the public.

Security of your Personal Information

Fleet secures your personal information from unauthorized access, use or disclosure.

Children Under Eighteen

Fleet does not knowingly collect personally identifiable information from children under the age of eighteen. If you are under the age of eighteen, you must ask your parent or guardian for permission to use Fleet's website or software.
